

- **2** Company reserves the right to deem equipment not worth repairing based on factors such as age and condition, in which even the price and service plan will be credited toward new equipment sold and installed by Campbell Cooling.
- **3** Annual preventative maintenance will be scheduled during normal working hours, Monday through Friday. These plans are non-transferable to new owners if the house is sold and are non-refundable. Further, the plan is void if any person, including owner, renders service to equipment except instructed by us.
- 4 Company shall not be responsible for customer's failure to use ordinary care in the operation of any cooling system. Such as, but not limited to, replacing blown fuses, resetting breaker switches, or turning on and off power switches.
- **5** Account must be current.
- **6** Our obligation to service and replacement of parts is subject to location accessibility and parts availability through normal sources of supply.
- **7** This plan may be terminated by Company [A] if service is afforded by anyone other than Company, [B] if customer fails to comply with Company credit terms.
